FINANCE INFORMATION SHEET

Registration Fees, Tuition, and Payment Plans for Distance Learning Students Worldwide

Introduction

Great Commission Christian University (GCCU) is committed to keeping quality Christian higher education affordable and accessible to distance learning students at every one of our study centers worldwide. This Finance Information Sheet sets out, clearly and in full, the registration fees, program/tuition fees, per-course fees, and installment payment plans applicable to each certificate, diploma, degree, and professorship program.

All fees stated below are in United States Dollars (US\$) and apply specifically to Distance Learning students. Fees are broken into manageable installments so that no student is prevented from pursuing their education by the cost of a single lump-sum payment.

FEE SCHEDULE BY PROGRAM LEVEL

The table below states the Registration Fee, total Program/Tuition Fee, program duration, and the number of installments available for each level of study.

PER-COURSE FEE — DISTANCE LEARNING

In addition to the Registration Fee, individual distance learning courses are charged separately at the following rate:

Item	Fee
Per Course Fee (Distance Learning)	US\$5.00 – US\$10.00 per course

The exact per-course fee depends on the course level and materials required, and will be confirmed at the time of course registration.

UNDERSTANDING THE INSTALLMENT PAYMENT PLAN

To make payment manageable, GCCU allows students to pay their Registration Fee and Program/Tuition Fee in installments rather than as a single payment, as follows:

1. Certificate Programs — Total fee of US\$200.00 payable in six (6) equal installments across the two-semester program.
2. Diploma Programs — Total fee of US\$200.00 payable in up to six (6) monthly installments across the six-month program.
3. Bachelor's Degree — US\$250.00 per semester, payable in two (2) to three (3) installments within each semester.
4. Master's, Doctorate, and Professorship tracks — Registration fee payable in installments to be arranged directly with the Office of Finance.

Students who prefer to pay the full Registration Fee or Program Fee at once may do so at any time; there is no penalty for early or lump-sum payment.

COURSE ACCESS AND MODE OF STUDY

GCCU offers distance learning students flexibility in how they access their coursework and attend classes. Students may choose any one, or a combination, of the following:

1. Course Portal — Access all course materials, assignments, and resources through GCCU's dedicated online courses portal.

2. Email Delivery — Course materials may also be sent directly to students via email upon request. Or hard copies ship to you to your country if you can under take the cost.
3. Self-Study — Students may complete coursework independently, at their own pace, from home.
4. Live Virtual Classes — Students may attend scheduled live online classes with instructors and fellow students.
5. In-Person Study Centers or campus base program— Students may attend classes in person at any GCCU study center located within their own country.

ADMISSION PROCESS

GCCU is committed to removing financial barriers at the point of entry. The following steps are completely free of charge to all applicants:

1. Submission of the Admission Application Form.
2. Completion of the Online Aptitude Test.
3. Initial review and evaluation by the Office of Admissions.

No applicant is charged a fee to apply, sit the aptitude test, or receive an admission decision. Fees apply only once a student proceeds to registration for a specific program, as outlined in the Fee Schedule above.

HOW TO MAKE PAYMENT

Students who are ready to make payment toward their Registration Fee, Tuition Fee, or per-course fee may do so using either of the following methods:

Option 1 — Direct Bank Transfer

Payments may be transferred to the official account bearing the name of the University Chancellor, as detailed below. Please contact the Office of Finance to receive full account details before sending payment. We will make payment to our official bank account after we have receive
